- c. possesses qualification and experience as specified in Rule (5)

As per Section 48 of the Mental Health Care Act, 2017 A member of the State Authority may, by notice in writing under his hand addressed to the State Government, resign his office.

Provided that a member shall until he is permitted by the State Government to relinquish his office sooner, continue to hold office until the expiry of 3 months from the date of receipt of such notice or, until a person duly appointed as his successor enters upon office or until the expiry of his term of office, whichever is earliest.
