#### **ESSENTIAL QUALIFICATION:**

The candidate for the post of Peon must have passed Middle Standard Examination and possess knowledge of Hindi/Punjabi.

#### **AGE LIMIT:**

The candidate should not be less than 18 years and more than 42 years of age as on 01.01.2020. Relaxation in age will be given to the candidates of reserved categories as per the Haryana Government instructions.
