 - The eligibility of such candidates who are working in PSUs or other Govt. Organizations where Industrial/ Variable Dearness Allowance pattern is applicable, shall be determined by equating their IDA/VDA pattern pay scale with the requisite CDA pattern pay scales as being normally done.
 - iv. The age of the candidate shall not exceed 56 years as on last day of submission of application.
 - v. The Commission reserves the right not to fill the above-mentioned vacancy.
