Subject: - **Applying for Financial Assistance for the students of weaker financial status.**

Applications are invited from the students of weak financial backgrounds of university teaching departments for the grant of Financial Assistance from Students Welfare/Aid Fund. The students are required to apply in the prescribed Performa (at flag-A). The Financial Assistance may be granted on the basis of the following criteria/procedure subject to availability of funds :-

1. The assistance is provided to the students who are not covered under any scheme, i.e., Scholarships/Fee Reimbursement/any other Financial Assistance by the concerned department etc. The student will submit an undertaking stating that he/she has not availed the financial assistance from any other source.
2. The preference is given to the students who have lost one or both of the parents and do not have any financial support from any other corner.
3. The preference is given to the students who submit the Income certificate that their income is up to 1.5 lac (Annually) issued by the First Class Executive Magistrate.
4. The financial assistance is not provided to the students whose parents are not covered under the slab of Income Tax.
5. The financial assistance is not provided to the students who have indulged in any incident of misconduct/misbehavior with teachers, employees or fellow students, and should not have used unfair means in examinations.
6. The prescribed Performa can be downloaded from the University website.

All the needy students are requested to apply for financial assistance in the prescribed Performa on next page. The students should also attach all the required documents. The **needy students should send their applications on the** e-mail dsw@gjust.org latest by 12 November 2020. The chairpersons are requested to notify and inform the students of their departments.
