Applications are invited from eligible candidates on plain paper in prescribed form attached with this advertisement for filling up 13 (Thirteen) posts of Peons/Addl. Peons (**General Category=07, ESM General Category=01, SC=02, BC-A=02, BC-B=01**) purely on temporary basis but likely to be on permanent basis, in FPL-DL\*\* (16900-53500) plus other allowances as admissible to Haryana Government Employees from time to time, which denotes for Group-D, for Sessions Division, Panipat. In case of non-availability of suitable Ex-Servicemen, their dependants i.e wives, sons and daughters subject to their fulfilling all conditions of qualifications, age etc. shall be considered against the posts meant for Ex-Servicemen. Further that in case of non-availability of suitable candidates from reserved categories, vacancies meant for such categories shall be filled up from the candidates belonging to General category.

The educational qualification and age for the aforesaid posts would be as under:-

1. **EDUCATIONAL QUALIFICATION:**

Middle standard with knowledge of Hindi/Punjabi.


2. **AGE:**

The candidate should not be less than 18 years and more than 42 years of age as on 30.11.2020. Upper age limit is, however, relaxable, as per instructions of the Haryana Government issued from time to time.
